

## *Notes for contributors*

All proposed contributions must be submitted to the Editorial Office at the following email address: [newmedit@iamb.it](mailto:newmedit@iamb.it).

The Journal requires authors to submit two versions of the article file: a complete text including title, figures and tables for anonymous review, and a non-anonymous manuscript file including title, JEL Code, author names, institutional affiliation, abstract, keywords, main text, indications of figures and tables and references. Figures and tables will be attached in a separate file in original format.

Manuscripts should be prepared according to the instructions below:

**LANGUAGE:** English or French.

**AUTHOR NAME(S):** full name(s) of the author(s) (Name, Surname), without abbreviations, institutional affiliation, affiliation address and e-mail.

**CORRESPONDENCE ADDRESS:** full contact details of the corresponding author (Institution, telephone number, fax number and email address) and mailing address to which messages and free copies should be sent.

**HEADINGS:** the following headings should be provided in the manuscript: introduction, paragraphs (materials, methods, description, results and discussion) with a short title, conclusions, acknowledgments (if required), references. All the headings should be numbered.

**TITLE:** concise but enough detailed, without abbreviations.

**ABSTRACT:** in English and French, regardless of the article language. The length should not exceed 900 characters (including spaces).

**JEL code:** Journal of Economic Literature ([JEL](#)) Classification System should be used. Max 3 codes.

**KEYWORDS:** the use of [AGROVOC](#) thesaurus is suggested. Max 5 words.

**REFERENCES:** they should include only publications mentioned in the text of the manuscript.

Citations in the text should observe the usual format requirements: (Tietenberg, 1992; Bockstaller and Girardin, 2003; Hansen *et al.*, 2012). References to unpublished information (reports, personal communications, etc.) should be reported in parentheses in the text: (Rossi, pers. comm., 1987). The number of references should be proportional to the text length (max 40).

Reference style:

*Periodical:* Bockstaller C. and Girardin P., 2003. How to validate environmental indicators. *Agricultural Systems*, 76(2): 639-653.

*Book:* Tietenberg T., 1992. *Environmental and natural resource economics*. 3<sup>rd</sup> ed. New York: Harper Collins.

*Book chapter:* Eymard-Duvernay F., 1995. La négociation de la qualité. In: Nicolas F. and Valceschini E. (eds). *Agroalimentaire : une économie de la qualité*. INRA, Paris, 39-48.

If there are more than two authors, the first name will be followed by *et al.* in the text but the names should be spelt out in full in the reference list.

Abbreviated titles of periodicals should conform to the rules of World List of Science Periodicals.

**TABLES:** tables included in the text should be numbered consecutively with an explicative title, units of measurement, a legend and relative references written in italics. Tables must be attached separately in the file in original format (Excel, Word). Ex: Table 1. *Title*

**GRAPHS AND DRAWINGS:** graphs and drawings included in the text should be in black and white, with titles of axes and without any outline, grid or background in the tracing area. Graphs must be attached separately in the file in original format (Excel). Ex: Graph 1. *Title*

**ILLUSTRATIONS:** photographs (slides, preferably), rigorously in black and white, should be numbered and lettered. They must be attached separately.

**NOTES:** they should be printed as footnotes, numbered consecutively and referred to in the text by superscripts.

**LENGTH:** from 35,000 to 45,000 characters max (including spaces). The number of illustrations, tables and graphs should be proportional to the length of the text.

**OFF-PRINTS:** 3 free paper copies will be supplied to the authors. Additional off-prints can be ordered.
